All this is to be done in front of web camera and with the permission & satisfaction of the invigilator. During the entire examination the student shall keep the web camera and microphone in "On mode" and no other person is allowed in 9 the room where the candidate is sitting to write the answers. The candidate is not allowed to take help of any study material. All this is to be done a period of three hour duration. No extra time is allowed for scaling of answer sheets.
