They also have well equipped testing facilities regarding memory, IQ, attention concentration and brain dysfunction.

Dayanand College, Hisar, a Government Aided College established in 1950, Governed by **DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar** and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at **Hisar, Haryana**, through its **Principal, Dr. Vikramjit Singh**, hereinafter called the "DNC" and the department of psychology of DNC established in 1987 and offered graduation course of B.A in psychology subject(which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part.

WHEREAS:

The Parties confirm their intentions in good faith as follows :-

1. Objectives of MoU:

- 1.1 To provide the practical knowledge to the students of psychology.
- 1.2 To inculcate a feeling of responsibility and paying back to the society among the students of psychology.

3. Duration of MoU

The Duration of MoU will be till 30th May, 2028. Both the parties may extend the duration after 30th May, 2028 with mutual consent.

4. Responsibilities of Department of Psychology, DNC, Hisar


- 4.1 Department of Psychology intends to provide practical knowledge and exposure in various therapeutic techniques, testing, psychological counselling and psychiatric rehabilitation to the students of Psychology.
- 4.2 Department of Psychology will provide a large scale platform to the Brain and body analysis centre, Hisar for conducting the awareness programme, workshops and seminars.
- 4.3 Department of Psychology also intends to refer clients to Brain and Body Centre, Hisar for counselling and psychological help.
- 4.4 The Department of Psychology will send their students for internship/projects etc. to Brain and Body Centre, Hisar.

5. Responsibilities of Brain and Body Centre, Hisar.

- 5.1 Brain and Body Analysis Centre is a well-equipped diagnostic, testing and psychiatric rehabilitation centre where graduate students of DNC can get proper exposure and understanding of testing, psychiatric rehabilitation, therapeutic expertise, individual counselling, relationship counselling and family counselling.
- 5.2 They have also agreed to provide exposure as well as providing internship training to the students of psychology department.
- 5.3 Brain and Body Analysis Centre agreed upon to aware our college students through awareness programmes, seminars and workshops on different psychological issues.
- 5.4 Brain and Body Analysis Centre has agreed that they would provide exposure to the students free of cost and they would not charge any financial fees or remuneration for their services. There will no financial liability of any of the party on issues related to MOU.
- 5.5 Brain and Body Analysis Centre will submit the attendance of students of psychology and the students shall submit a copy of his or her report of case study of clients and training in the centre.

The MoU shall be executed in duplicate with each copy being an official version and having equal legal validity. By Signing below, acting by their duly authorized officer, have caused this Memorandum of understanding to be executed, effective as of the day and year fist above written.
