This Memorandum of understanding ("MoU") is entered into on the 5th May, 2023 by and between RAAH GROUP FOUNDATION, TALWANDI RANA, HISAR

For RAAH GROUP FOUNDATION

"RAAH GROUP FOUNDATION" registered under registration Act, 1860 having its registered office at selpar sadan, Talwandi Rana, Hisar, Haryana. Helpline No: 098969-9991. Through its Foundation Chairman Naresh Selpar, here in after referred to as "RGF" (which expression shall, unless repugnant to the context thereof mean and include its successors and assigns) of the first part.

And

Dayanand College, Hisar, a premier co-educational institute of knowledge since 1950 "DNC" (which expression shall, unless repugnant to the context thereof mean and include its successors and

The college is a multidisciplinary co-educational institution with all the three facilities of Arts, Science and commerce both at under graduate (U.G.) and Post Graduate (P.G.) Level. The college is affiliated to Guru Jambheshwar University of Science and Technology, Hisar and is under section 2(f) and 12 (B) act of U.G.C.

WHEREAS :-

The parties confirm their intentions in good faith as follow:-

Objectives of MoU

The objectives of MoU are:

- a. To develop the sports culture.
- b. To promote local sports of Haryana.
- c. To organize various events like marathon and to honor the sports persons/ athletes.
- d. To promote local culture of Haryana and to develop feeling of regard and love for native culture.

Proposed Modes of collaboration

RAAH GROUP AND DAYANAND COLLEGE, HISAR will collaborate through the following:

- a. Cooperation and promotion of education and Sports to the students of Physical Education and sports.
- b. Training and competition of athletes.
- c. Participation in Sports Competition and Camps.

Term and Conditions

- Both the collaborating institute will provide opportunity to UG/PG students to conduct training in their playgrounds.
- DNC, Hisar will announce the information of medals through different communication medium (College Website and notices).
- There will be a discussion on the financials involved before any event. However, the college shall not be responsible for any financial expenditure.

4. Confidentiality and Non-disclosure

- a. A Party in receipt of confidential information from the other Party must not use or disclose the other party's confidential information without that other Party's prior written consent other than:
 - (1) For the purposes of carrying out this MoU, provide any disclosure is only to such of the receiving party's personnel who need to know and who are made subject to the confidentiality requirements of this MoU; or

(2) As required by law.

- b. Any public announcement in relation to this MoU should be made only after informing the other party.
- Confidential information means (a) the subject and terms of this MoU and (b) all C. information (in whatever form) disclosed by one party to the other, whatever before or after the date of this MoU but excludes information which (1) is or becomes public knowledge other than through a breach of this MoU (2) the recipient can show to the discloser's reasonable satisfaction to have been in the recipient's lawfully possession prior to disclosure or (3) the recipient can show to the discloser's reasonable satisfaction to have been lawfully received from a third party not obliged to keep that information confidential.

Duration of MoU

The duration of MoU will be from 13.04.2023 to 12.04.2026. Both the parties may extend the duration after 12.04.2026 with mutual consent.

Coordinators

Both institutes will designate person(s) who shall be responsible for co-ordination and implementation of this agreement.

Signed in Duplicate

The MoU shall be executed in duplicate with each copy being an official version and having equal legal validity. By signing below, acting by their duly authorized officer, have caused this Memorandum of understanding to be executed, effective as of the day and year fist above written.

Non exclusivity

This MoU is non-exclusive and the parties are free to enter into MoU/Agreements with other parties covering collaboration and co-operation within the scope of this MoU.

Governing Law

This MoU shall be governed by and construed in accordance with the laws in India. Without prejudice to any other binding agreement between the parties, any disputes arising out of this MoU shall be amicably resolved by negotiation between the parties. In case of dispute not resolved amicably within 30 days of occur of the dispute then same shall be referred to arbitration of one arbitrator if agreed upon and if not to three arbitrators, one to be appointed by each party and the third to be appointed be the said two arbitrator and the arbitration will be governed by the Arbitration and conciliation Act, 1996. The place for arbitration shall be at Hisar (Haryana) and language shall be in English.
