MEMORANDUM OF UNDERSTANDING

DAV Public School, Hisar having its registered office at Kamiri Road, Hisar Governed by DAV College Managing Committee, New Delhi, Affiliated to CBSE (No. 532026 Dated 28/2/2022) through its Principal, Sh. Sunil Sharma herein referred to as "DAV" (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the First Part ;

AND

Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its Principal, Dr. Vikramjit Singh, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part

WHEREAS:

The Parties confirm their intentions in good faith as follows :-

1. Objectives of MoU:

- 1.1 To provide and enhance academic interest to DAV by DNC students and teachers.
- 1.2 To inculcate a feeling of responsibilities and paying back to the society among the students and teachers of DNC.

2. Proposed Modes of Collaboration.

- 2.1 The Students and teachers of DAV can visit laboratories and other infrastructure of DNC for the upgradation of their knowledge.
- 2.2 The Management of DAV can invite the teachers of DNC for extension lectures.
- 2.3 The Students of DAV can visit the History Achieves/Museum/Exhibition conducted by DNC.

2.4 DNC will send its teachers as Subject Experts for the interviews at the beginning of the new session.

3. Coordinators

Both Institutes will designate person(s) who shall be responsible for coordination and implementation of this agreement.

4. Duration of MoU

The Duration of MoU will be till 30th May, 2026.

Both the parties may extend the duration after 30th May, 2026 with mutual consent.

5. Entry in to Effect, Modification and Termination:

5.1.1. The MoU shall become effective on the date it is signed by the parties and shall be valid for **three** years extendable further on mutual consent. Both parties shall review the status of the MoU at the end of every one-year period to determine any modification, whenever necessary. The MoU may be terminated with immediate effect by mutual agreement between the parties or by either party giving the other not less than 'three months' notice in writing.

5.1.2. All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.

5.1.3. No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.

5.1.4. This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.


6. Signed in Duplicate

This MoU is non-exclusive and the parties are free to enter into MoU/Agreements with other parties covering collaboration and co-operation within the scope of this MoU.





