Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its Principal, Dr. Vikramjit Singh, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part

WHEREAS:

The Parties namely, Self Defense Society and Physical Education of DNC confirm their intentions in good faith as follows:-

1. Objectives of MoU:

- 1.1 SDS faculties will provide guidance and training to the students of DNC for the games of Taekwondo & Wushu.
- 1.2 To inculcate a feeling of confidence and security among the students of DNC.

2. Proposed Modes of Collaboration.

- 2.1 The students of DNC will visit the center in Barwala as per their needs.
- 2.2 The faculties of SDS will train the students of DNC through camps and workshops.
- 2.3 The expenditure incurred for traveling to Barwala will be borne by DNC.

3. **Coordinators**

Both Institutes will design at person(s) who shall be responsible for coordination and implementation of this agreement.

4. **Duration of MoU**

The Duration of MoU will be till 30th May, 2026. Both the parties may extend the duration after 30th May, 2026 with mutual consent.

5. **Entry in to Effect, Modification and Termination:**

No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.

6. **Signed in Duplicate**

The MoU shall be execute in duplicate with each copy being an official version and having equal legal validity. By Signing below, acting by their duly authorized officer, have caused this Memorandum of understanding to be executed, effective as of the day and year first above written.


7. **Nonexclusivity**
