3. Coordinators

4. Duration of MoU

The Duration of MoU will be till 30th May, 2026. Both the parties may extend the duration after 30th May, 2026 with mutual consent.

5. Entry in to Effect, Modification and Termination:

No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.

6. Signedin Duplicate

The MoU shall be execute in duplicate with each copy being an official version andhaving equal legal validity. By Signing below, acting by their duly authorized officer, have caused this Memorandum of understanding to be executed, effective as of the dayandyear fistabove written.

This MoU is non-exclusive and the parties are free to enter into MoU/Agreements withotherparties covering collaboration and co-operation within the scope of this MoU.
