1. THE AGREEMENT

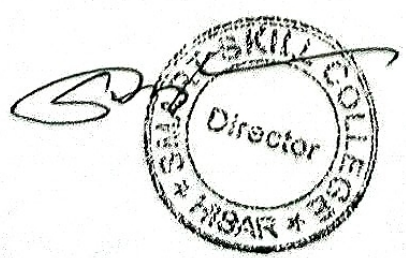

1.2 The Department of Commerce Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its Principal, Dr. Vikramjit Singh, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part

2. PREAMBLE

2.1 WHEREAS The Department of Commerce, DNC, Hisar have developed a facility for Teaching and Research in the areas of commerce and have qualified faculty.

2.2 AND WHEREAS The Department of Commerce DNC, Hisar and Smart Skill College, Housing Board, near Sector 14, Hisar agree to extend mutual co-operation on terms and conditions hereinafter contained.

3. SCOPE OF AGREEMENT

- 3.1 This agreement details the modalities and the terms and conditions for imparting skill and enhancing co-operation between **Smart Skill College, 161, Housing Board Colony, near Sector 14, Hisar** and **The Department of Commerce, DNC, Hisar**, the rights and obligations of either PARTY thereto and other arrangements between the Parties.
- 3.2 The MOU shall come into force from the date of signing of this agreement (hereinafter called the **effective date**) and shall remain valid for 3 years or until superseded or cancelled.
- 3.3 This MOU will be applicable for students (UG) of **The Department of Commerce, DNC, Hisar** for skill learning and enhancing their employability.

4. RESPONSIBILITIES OF THE DEPARTMENT OF COMMERCE, DNC, HISAR AND SMART SKILL COLLEGE, HISAR

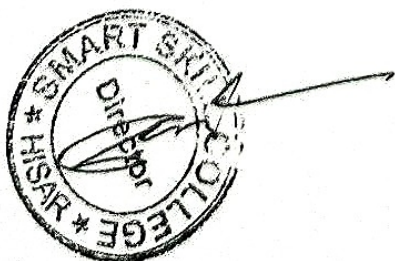
- 4.1 **SS College, Hisar** shall recognize **DNC, Hisar** as an academic institute par excellence rendering, thousands of students, quality education.
- 4.2 **The Department of Commerce, DNC, Hisar** shall recognize **SS College, Hisar** as a skill training center par excellence
- 4.3 Students of the **Department** shall be skilled and trained by the **SS College, Hisar**, in **Banking and financial sector skill council**
- 4.4 The utilization of Infrastructure & Other facilities of either party shall be scheduled and utilized based on the mutual consent.
- 4.5 The students shall submit a copy of his/her Skill learnt Certificate to the **The Department of Commerce, DNC, Hisar** and the **SS College, Hisar**.
- 4.6 There shall be no financial obligation/ liability on any of the Parties signing the MoU.

5. TERMINATION OF AGREEMENT

The MOU shall be effective from the date of its signing by both the parties and shall remain in operation until either Party serves notice to the other for its intention to terminate it. In such events, the **MOU shall stand terminated at the end of one calendar month from the date of issue of such notice**. In case both the Parties agree to terminate the MOU, the on-going skill training programs shall be allowed to be completed.

6. AMENDMENTS TO THE AGREEMENT

The Parties to this MOU may, by mutual consent, add, modify, amend or delete any word, phrase, sentence or Article in this MOU at any time during the operation of MOU.
