**1. THE AGREEMENT**

1.1 THE AGREEMENT made and entered into on dated 10/05/23....., between Smart Skill College, having its registered office at 161, Housing Board Colony, near Sector 14, Hisar, registered under Jambh Shakti Trust, (Registration No AABTJ5505GE20221, through its Director Sh. Vikas Godara, hereinafter called "SS College, Hisar" (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the First Part.

1.2 The Departments of Political Science and Public Administration, Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its Principal, Dr. Vikramjit Singh, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part

**2. PREAMBLE**

WHEREAS Departments of Political Science and Public Administration, DNC, Hisar have developed a facility for Teaching and Research in the areas of Politics and Administration and have qualified faculty.

AND WHEREAS Departments of Political Science and Public Administration, DNC, Hisar and Smart Skill College, Housing Board, near Sector 14, Hisar agree to

extend mutual co-operation on terms and conditions hereinafter contained.

### 3. SCOPE OF AGREEMENT

This agreement details the modalities and the terms and conditions for imparting skill and enhancing co-operation between **Smart Skill College, 161, Housing Board Colony, near Sector 14, Hisar** and **Departments of Political Science and Public Administration, DNC, Hisar**, the rights and obligations of either PARTY thereto and other arrangements between the Parties.

The MOU shall come into force from the date of signing of this agreement (hereinafter called the **effective date**) and shall remain valid for 3 years or until superseded or cancelled.

This MOU will be applicable for students (UG) of **Departments of Political Science and Public Administration, DNC, Hisar** for skill learning and enhancing their employability.

### 4. RESPONSIBILITIES OF DEPARTMENTS OF POLITICAL SCIENCE AND PUBLIC ADMINISTRATION, DNC, HISAR AND SMART SKILL COLLEGE, HISAR

SS College, Hisar shall recognize DNC, Hisar as an academic institute par excellence rendering, thousands of students, quality education.

The **Departments of Political Science and Public Administration, DNC, Hisar** shall recognize SS College, Hisar as a skill training center par excellence

Students of both the **Departments** shall be skilled and trained by the SS College, Hisar, in

- i. NGO Management; and
- ii. Public Relations Management

The utilization of Infrastructure & Other facilities of either party shall be scheduled and utilized based on the mutual consent.

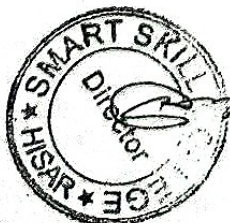

### 5. TERMINATION OF AGREEMENT

In such events, the MOU shall stand terminated at the end of one calendar month from the date of issue of such notice. In case both the Parties agree to terminate the MOU, the on-going skill training programs shall be allowed to be completed.

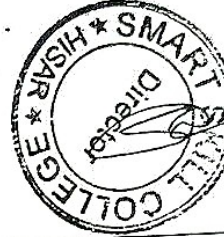
