Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its Principal, Dr.Vikramjit Singh, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part

WHEREAS:

The Parties confirm their intentions in good faith as follows: -

1. Objectives of MOU:

- 1.1 To provide and enhance academic interest between DBH and DNC.
- 1.2 To encourage students to opt for Journalism and Mass communication course in DNC.
- 1.3 To promote research/internship/placement activities between DBH and DNC.

2. Proposed Modes of Collaboration:

- 2.1 Both Parties Shall Allow the resource facilities to be used for academic activities by following institute rules.
- 2.2 DBH Will Provide training and Internship opportunity to UG/PG students.

4. Relationship between the Parties:

4.1 Implementation:

All laws, rules and regulations issued by the parties shall be strictly observed at all times.

4.2 Indemnity:

Both parties agree to indemnify/ compensate other party on account of any losses arising due to the fault of the other party.

4.3 Coordinator:

Both Institutes will designate person(s) who shall be responsible for coordination and implementation of this agreement. The Incharge, Department of Mass Communication, DNC, Hisar will be the coordinator from the DNC, Hisar.

5. Entry in to Effect, Modification and Termination:

- 5.1 This MOU shall become effective on the date it is signed by the parties and shall be valid for five years extendable further on mutual consent. Both parties shall review the status of the MOU at the end of every two-year period to determine any modification, whenever necessary. The MOU may be terminated with immediate effect by mutual agreement between the parties or by either party giving the other not less than 'three months' notice in writing.
- 5.2 All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.
- 5.3 No amendment or modification of the MOU shall be yalid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MOU. The modifications/changes shall become part of the MOU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.
