SCOPE OF AGREEMENT

Responsibilities of Department of Economics, DNC, Hisar and MKG Electronics

- 4.4 Faculty of any of the institution may also act as Advisor/Supervisor or /and Co-Advisor/Co-Supervisor for guiding the students of UG for research work and projects.
- The student shall submit a copy of his/her project report/training report to The Department of Economics, DNC, Hisar and MKG Electronics, PlotNo 122, Gali No-2, Ganesh Nagar Industrial Area, Hisar-125001
- 4.6 The student shall be required to submit 'No Dues Certificate' from the Co-Major Advisor/
 Co-Supervisor before the institute allows submission of the project/training report.
- 4.7 The Department of Economics, DNC, Hisar and MKG Electronics, PlotNo 122, Gali No-2, Ganesh Nagar Industrial Area, Hisar-125001 shall allow the library and other facilities to be used by faculty of collaborating university/college/institution for academic activities by following Institute rules.
