### 3. Coordinators

### 4. Duration of MoU

The Duration of MoU will be till 30<sup>th</sup> May, 2026.

Both the parties may extend the duration after 30<sup>th</sup> May, 2026 with mutual consent.

### 5. Entry in to Effect, Modification and Termination:

No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.



This MoU is non-exclusive and the parties are free to enter into MoU/Agreements with other parties covering collaboration and co-operation within the scope of this MoU




