





MEMORANDUM OF UNDERSTANDING BETWEEN

Whereas the Parties confirm their intentions in good faith as follows:

1. SCOPE OF AGREEMENT

- 1.1 This agreement details the modalities and the terms and conditions for academic cooperation between **Department of Mass Communication**, **DNC** and **OKF** the rights and obligation of either PARTY thereto and other arrangements between the parties.
- 1.2 The MOU shall come into force from the date of signing of this agreement (hereinafter called the effective date) and shall remain valid for 5 years or until superseded or cancelled.
- 1.3 This MOU will be applicable for students of Department of Mass Communication, DNC, Hisar and OKF for academic and research work and vice versa.

2. PROPOSED MODES OF COLLABORATION

- 2.1 The utilization of co-production, Infrastructure, resource sharing, shooting purposes & other facilities of either party shall be scheduled and utilized base on the mutual consents.
- 2.2 DNC and OKF shall allow its infrastructure and facilities to be used by the students registered in the DNC.
- 2.3 OKF shall provide internship/training/placement/project work to the students of DNC, depending upon the available facilities.
- 2.4 Collaborative effort will made for the extensive work in the field of Film communication to enhance the students participation.
- 2.5 Long term advantage towards this collaboration is to build "Film hub" in the College with the help of OKF for technological understanding of Film World.
- 2.6 Expertise of the institutions will provide necessary help to organize 'Workshops' and seminars so that to shape the creative part of students.
- 2.7 DNC and OKF shall organise Film Festival in near future.
- 2.8 Students of DNC will know the Film Production/ Film Marketing and other acas related to the field.

3. INTELLECUTUAL PROPERTY

Intellectual property, research publications and benefits arising out of commercialization of technologies generated out of co-operation under this agreement shall be jointly owned by DNC and OKF or as per guidelines of the funding agency on mutually agreeable terms.

4. TERMINATION OF AGREEMENT

The MOU shall be effective from the date of its signing by both the parties and shall remain in operation until either Party serves notice to the other for its intention to terminate it. In such events, the MOU shall stand terminated at the end of one calendar month from the date of issue of such notice. In case both the Parties agree to terminate the MOU, the on-going thesis or research work shall be allowed to be completed.

5. AMENDMENTS TO THE AGREEMENT

The Parties to this MOU may by mutual consent add, modify, amend or delete any word, phrase, sentence or article in this MOU at any time during the operation of MOU.
