3 SCOPE OF AGREEMENT

- This agreement details the modalities and the terms and conditions for academic and training co-operation between The Department of Physics, DNC, Hisar and Modern Automobiles, Hisar, Delhi Road, Hisar-125001, the rights and obligation of either PARTY thereto and other arrangements between the parties.
- 3.2 The MOU shall come into force from the date of signing of this agreement (hereinafter called the effective date) and shall remain valid for 3 years or until superseded or cancelled.
- This MOU will be applicable for faculty/teachers and UG students of The Department of Physics, DNC, Hisar and Modern Automobiles, Hisar, Delhi Road, Hisar-125001 for research work and marketing, training, finance, Human resource.
- 4. Responsibilities of Department of Physics, DNC, Hisar and Modern Automobiles, Hisar
- The Department of Physics, DNC Hisar shall recognize Modern Automobiles, Hisar, Delhi Road, Hisar-125001 for training in marketing & finance, training in automobiles & human resource as an academic and research centre at par with the Academic Departments of DNC, Hisar and faculty of Modern Automobiles at par with Faculty of DNC, Hisar for academic and research work and vice versa.
- Both the collaborating institutes will provide opportunity to UG students to conduct training and research in Modern Automobiles, Hisar. Students of DNC will be required to nominate a faculty member of DNC, Hisar as Co-Advisor/Co-Supervisor/Co-Guide and office members of Modern Automobiles will appoint a Co-Advisor/Co-Supervisor/Co-Guide to provide training / research/ project work to the students.

The necessary consumables, if required, shall be provided by DNC, Hisar to the Students as and when decided by the collaborating institution Heads/Principals, subject to availability without affecting the normal working of the respective departments. The costs and expenditure or project contingencies will be borne/provided by DNC Hisar.

Faculty of any of the institution may also act as Advisor/Supervisor or /and Co-Advisor/Co-Supervisor for guiding the students of UG for research work, training and projects.

The student shall submit a copy of his/her project report/training report/ research work to The Department of Physics, DNC, Hisar and Modern Automobiles, Hisar, Delhi Road, Hisar-125001.

4.6

The student shall be required to submit 'No Dues Certificate' from the Co-Major Advisor/ Co-Supervisor before the institute allows submission of the project/training report.

4.7

The Department of Physics, DNC, Hisar and Modern Automobiles, Hisar, Delhi Road, Hisar-125001 shall allow its infrastructure and facilities to be used by the students registered for UG classes in DNC, Hisar

4.8

The Department of Physics in DNC, Hisar and Modern Automobiles, Hisar, Delhi Road, Hisar-125001 shall provide training/project work/ research work to undergraduate students of DNC, Hisar and vice versa, depending upon the available facilities and staff.

Responsibilities of DN College, Hisar:-

- To promote the partnership and communicate the opportunities available to students.
- To identify potential opportunities for collaboration with the industrial organization.
- To facilitate the participation of students in internships, training programs, and workshops offered by the industrial organization.
- To collaborate with the industrial organization on research projects of mutual interest.
