

## MEMORANDUM OF UNDERSTANDING

Kalakar Art Crew, Hisar having its registered office at Hisar through its **President, Sh. Lalit Vissarwal** herein referred to as "KAC" (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the first part.

AND

Dayanand College, Hisar, a Government Aided College established in 1950, Governed by DAV College Managing Committee, New Delhi, Affiliated to Guru Jambheshwar University of Science and Technology, Hisar and recognized by UGC Act, 1956 under Section 2(f) and 12(B), having administrative office at Hisar, Haryana, through its **Principal, Dr. Vikramjit Singh**, hereinafter called the "DNC", (which expression shall unless repugnant to the context or meaning thereof means and includes its successors and assigns) of the other part.

### **WHEREAS:**

The Parties confirm their intentions in good faith as follows: -

#### **1. Purpose of MoU:**

1. To provide training of Fine Arts through workshops and camps.
2. To develop creative thinking, broadening the mind and feeding the soul.
3. To strengthen students observational, drawing skills and recognition of the complexities and continual rearrangement of design elements.

**2. Roles and Responsibilities:**

Services to be rendered during the collaboration-

1. To promote artistic temperament among its stakeholders through various arts.
2. To provide platform for guest lectures on Fine Arts.
3. Conducting Fine Arts camp, workshops and exhibitions.

**3. Coordinators**

Both Institutes will designate person(s) who shall be responsible for coordination and implementation of this agreement.

**4. Duration of MoU**

The Duration of MoU will be till 30<sup>th</sup> May, 2026.

Both the parties may extend the duration after 30<sup>th</sup> May, 2026 with mutual consent.

**5. Entry in to Effect, Modification and Termination:**

No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/ executed, unless otherwise agreed upon.

This MoU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.

**6. Signed in Duplicate**

The MoU shall be execute in duplicate with each copy being an official version and having equal legal validity. By Signing below, acting by their duly authorized officer, have caused this Memorandum of understanding to be executed, effective as of the day and year fist above written.
