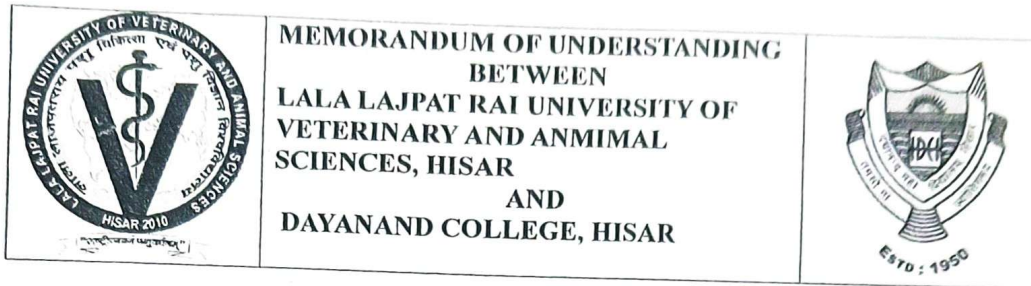

- 2.2. WHEREAS DNC, Hisar has developed a facility for teaching and research in the area of Biotechnology and has qualified faculty.
- 2.3. AND WHEREAS LUVAS, Hisar and DNC, Hisar agree to extend mutual co-operation on terms and conditions hereinafter contained.

**3. SCOPE OF AGREEMENT**

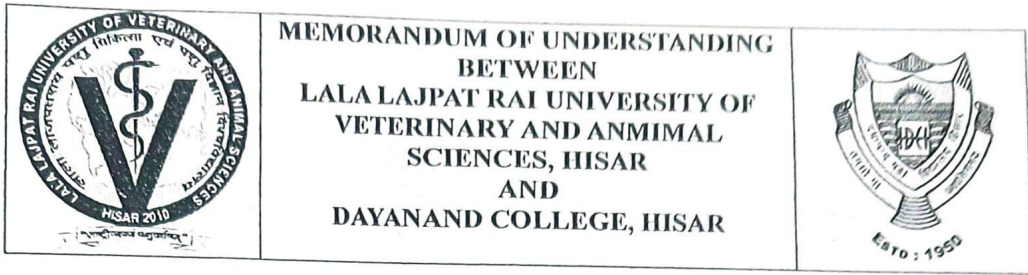

**2. PREAMBLE**


- 2.1. WHEREAS LUVAS, Hisar has developed a facility for research in the area of Veterinary and Animal Sciences and has eminent faculty.

- 4.2. Both the collaborating institutes will provide opportunity to UG/PG students to conduct teaching, training and research in their laboratories. LUVAS students will be required to nominate a faculty member of DNC, Hisar as Co-Major Advisor and DNC students will be required to nominate a faculty member of LUVAS as Co-Supervisor. In addition they will be required to complete M.Sc./B.Sc. projects works or training prescribed by LUVAS/DNC, Hisar.
- 4.3. The necessary chemicals/consumables, if required, shall be provided by the respective College/Institute. Major Advisor of PG students will plan and arrange necessary funds for laboratory supplies before getting PG student's synopsis approved.
- 4.4. The student shall submit a copy of his/her project report/training report to the LUVAS/DNC Library.
- 4.5. The student shall required to submit 'No Dues Certificate' from the Co-Major Advisor/ Co-Supervisor before institute allows submission of the project/training report.
- 4.6. LUVAS and DNC, Hisar shall allow the library and other facilities to be used by faculty of collaborating university for academic activities by following institute rules.
- 4.7. LUVAS/DNC, Hisar shall allow its infrastructure and facilities to be used by the students registered for PG classes in DNC/LUVAS, Hisar for his/her research activities, wherever faculty member of collaborating institutes is on the Advisory Committee of PG students.
- 4.8. DNC/LUVAS, Hisar shall provide training/project work to postgraduate students of Masters' and Undergraduate students (maximum twenty students in one academic session and maximum of two students for one faculty member) of LUVAS/DNC, Hisar depending upon the available facilities.
- 4.9. The students will be allowed to utilize the scientific material and physical facilities of each other institutes with the approval of the Head of the concerned Institute and it will not hinder the normal working/functioning of the institutes.


#### 5. INTELLECTUAL PROPERTY

Intellectual property, research publications and benefits arising out of commercialization of technologies generated out of co-operation under this agreement shall be jointly owned by LUVAS, Hisar and DNC, Hisar or as per guidelines of the funding agency on mutually agreeable terms.

#### 6. TERMINATION OF AGREEMENT

The MOU shall be effective from the date of its signing by both the parties and shall remain valid for 3 years or until either Party serves notice to the other for its intention to terminate it. In such events, the MOU shall stand terminated at the end of one calendar month from the date of issue of such notice. In case both the Parties agree to terminate the MOU, the on-going thesis or research work shall be allowed to be completed.


