#### 4. Responsibilities of Department of Psychology, DNC, Hisar

- 4.2 Department of Psychology will provide a large scale platform to the WISDOM OF MIND, Hisar for conducting the awareness programmes, workshops and seminars.
- 4.3 Department of Psychology also intends to refer clients to WISDOM OF MIND, Hisar for counselling and psychological help.
- 4.4 The Department of Psychology will send their students for internship/projects etc. to WISDOM OF MIND, Hisar.


#### Non exclusivity




